2010 Cosgrave Honoree in Class With Finch Founder

For honoree **Lady Hilary Winant Glidewell** and her husband, Sir Iain Glidewell, the 2010 Cosgrave event May 17 was a chance to reconnect with Finch Alumnae they had entertained in London several years ago.

During a Finch/England visit planned by **Thelma Wigoder Frye**, 2001 Cosgrave honoree, Lady Glidewell and her husband gave a dinner at London's New Cavendish Club, a private club that once catered to nurses serving in WWI. Finch Alumnae fondly remember the beautiful party, as they do the entire trip. Thelma, a long-time friend of the Glidewells, was unable to attend Cosgrave this year as she had in the past. A tireless traveler, Thelma was on her way to Israel in May.

Hilary, as Lady Glidewell prefers to be called, studied at Finch from 1940-42 and attended law lectures delivered by Finch founder **Jessica Garretson Finch**

Cosgrave. Hilary and her husband traveled the longest distance for the Cosgrave reception and dinner at the Cosmopolitan Club. The other honorees:

Dr. Jeanne Chenault Porter: 17th Century art scholar; Finch faculty 1972-1974 preceding 32 years at Penn State; inspired gallery owner, **Nohra Haime**, Finch '73 and Cosgrave '01.

Stephanie Brody-Lederman: B.S. in design from Finch, '61; her paintings grace museums around the world; has studios in Brooklyn and Paris.

Antoinette Walker Hamner: Philanthropist, civic leader and art collector in Vero Beach, FL.; B.A. in Spanish from Finch, '73.

Ann M. Holmes: Pioneer in medical communications in print and television; created and sold four companies; authored four books; Finch '71.

Barbara Richards Pitney: 1971

founded Wabba Travel, Basking Ridge, N.J.; designs tours for art and architecture patrons; has lived in Nigeria and Australia; Finch '60.

More than 100 guests attended the 16th annual Cosgrave awards. All funds raised went to the Finch Grants, which send outstanding women graduates of a two-year community college on to a four-year campus to complete their bachelor degrees. Cosgrave proceeds also help provide for an annual Finch Scholar, a part-time undergraduate office intern for the New York Women's Foundation.

Lois Moran Ziegler, chairman of the Finch College Alumnae Association Foundation, recently stated that because of such exceptional candidates, Finch will provide five (\$2,000 each) grants this year instead of the usual four. Successful fundraising efforts in many areas make this possible.

The annual Money Tree, conceived by **Carol Barnes Ross** and usually valued at \$1,000, was won by **Rebecca Even-Zohar**.

Following the awards presentation, outgoing Alumnae President **Cheryl Young Deknatel** bid her colleagues adieu after three years of leadership, appreciated by all, and welcomed her successor, **JoAnn Cricchio Kubat**.

Presentation of Awards

As each recipient of the Jessica Cosgrave Lifetime Achievement Award was announced, she stepped forward and acknowledged her honor.

Before leaving London for New York, Lady Hilary and Sir Iain Glidewell had celebrated their 60th wedding anniversary. Both are WWII veterans. Hilary, as a member of the Women's Royal Naval Service, worked aboard British troop ships decoding messages, while her husband (whom she met later) piloted American B-24 bombers for the Royal Air Force.

Hilary was the only Cosgrave honoree this year to have known Jessica Finch Cosgrave, Barnard College graduate who founded Finch in 1900, naming it after her first husband, James Finch. That marriage ended in divorce and in 1913 Jessica married famed journalist, John O'Hara Cosgrave, Sunday editor of the (former) *New York World*. The bride had earned a law degree at New York University and was giving mandatory lectures on law at Finch. The former

Hilary Winant was among her students from 1940-1942. Born of a British mother and an American father, Hilary temporarily left London for the United States as war threatened in Europe.

"The outbreak of WWII in 1939, took my mother and me and two younger sisters to New York," she said. "We had been at schools in France, England and Switzerland. I left England with an Oxford School certificate, which secured my entry into Finch College and the scholarship I was awarded. My only duties were to show visitors around and do some light office work. Bless Mrs. Cosgrave and her wonderful staff for my truly wonderful two years at Finch."

Retired art history professor Jeanne Porter said that of her more than three decades of teaching, her two years at Finch were the happiest of her career.

"I can hardly express how thoroughly honored and delighted I am to receive the Jessica Cosgrave Lifetime Achievement Award and this is because I so loved, still love and believe in Finch College," she said.

"There were so many exceptional and enjoyable things about Finch: Its very high academic quality, its pervasive friendly atmosphere on a scale that enabled faculty to really get to know their students, its rich national and international network, and its vibrant relationship with New York's numerous resources.

"Many delights were well-planned while others were impromptu or serendipitous, such as a sudden Bertolucci film in the afternoon, a mid-day concert

by pianist John Browning, or a lunchtime visit by Dick Cavett, who happened to encounter a couple of our students on the street."

As an art historian, Dr. Porter said she was grateful for the former Finch College Museum of Art, which "maintained a solid reputation in the art world".

"And I so enjoyed working with **Professor Marshall Mount**, who kept the closet in our shared office stocked with exotic African sculpture and whose wit and wisdom fueled our every endeavor."

Artist Stephanie Brody-Lederman also expressed her gratitude to Dr. Mount, who as usual was so loyal in attending the awards with his wife, **Caroline**.

"I am very honored after reading about the others. Me, I just draw pictures," said Stephanie, modestly. Her oil and acrylic paintings are part of public and private collections across the country and around the globe. She studied two years at the University of Michigan before enrolling at Finch. During the summer at home in New York after her sophomore year at Michigan, she met her future husband, Dr. Gerald (Jerry) Lederman, and decided to stay home and go to Finch.

"After 50 years of marriage, I think it was a good move," she said. "Jerry had a MG convertible that was black with red upholstery. He bought it in Libya, where he was stationed with the Air Force. He found it in the desert and the Navy shipped it home for him. He'd drive it out to Long Island in the summer. It was wonderful."

Of her multiple charitable endeavors in Vero Beach, FL., Antoinette (Toni)

Hamner is perhaps proudest of IMPACT 100, which she helped instigate more than two years ago. The original idea was for 100 women to each donate \$1,000 for a worthy project, but many more women took up the cause.

"In the first two years we raised \$450,000," said Toni, who is the second generation member of her family to attend Finch. Her mother, **Alethea Kunhardt Walker**, also of Vero Beach, was at Finch from 1945-47.

Toni and her husband, George F. Hamner, Jr., are prominent leaders in the social, civic, cultural and business lives of their community. George Hamner represents his family's fourth generation to own and operate Indian River Exchange Packers Inc. The company packs and ships grapefruit around the world, grown and picked from nearly 2,000 groves covering much of Florida's

Indian River County.

Ann M. Holmes recalled writing papers for tough professors, **Dr. Jean Ellis** and **Dr. Margaret Maxwell**, which eventually led to her outstanding success in business. She founded and sold several medical communications companies before retiring in 2003. One of them, MD/TV, was the first to produce a program on a specific medical topic, and it was the first in TV history to carry advertisements for prescription drugs.

Mrs. Cosgrave, a civil rights activist who relished marching for controversial causes, would have been thrilled to know that Ann was among Finch students who went to Washington in 1970 to protest the Vietnam War. She literally lived her government and history classes, in which she excelled.

Politics is also a vital interest of Barbara Pitney, co-founder of NJ Renaissance, now called the

Bernardsville Republican Club. Her home in Bernardsville, N.J., is close to Basking Ridge, N.J., where she established her Wabba Travel agency 39 years ago. Also inspired by Marshall Mount, Barbara creates private tours based on art and architecture. After graduating from Finch in 1960, she served as student-faculty liaison for the first Finch Intercontinental Study Plan (FISP), inaugurated by President **Roland R. DeMarco**. Not long afterward Barbara was living and working in Lagos, Nigeria, and later in Melbourne, Australia, as a young bride. Her first attempt at writing a guide book was enthusiastically received, as Lagos had never had one before.

The Cosgrave celebration was complemented by corresponding events before and after. They included a guided tour of the Central Park Conservatory Garden; a production of "Housewives of Mannheim," produced by 2007 Cosgrave honoree **Patricia Flicker Addiss**; a cocktail party given by 2003 honoree **Diana O'Rourke Jacoby** and her husband, Mark Jacoby, at their Philip Colleck antiques gallery, and a lecture by author Debra Pickrel, featuring her book, *Frank Lloyd Wright—The Plaza Years*.

Coming from California for Cosgrave was 2000 honoree **Alba Farber Francesca** and her husband, well-known actor James Karen. Alba, a leader in organizing the Finch/L.A. trip November 3-7, will host the first night's festivities with her husband in their home.

Community Service: Mary Beth Baker Busby

When Oklahoma City native, **Mary Beth Baker**, arrived in New York City to attend Finch in the late 1950s as a theater arts major, this aspiring actress could not have anticipated the dramatic events to come that would shape and change her post-college life forever. After all, with marriage to New York lawyer **David Busby** after graduation and the arrival of sons Robert in 1964 and Jack in 1965, life was indeed good.

But, by the time the children each reached the age of two, Mary Beth noticed that their mental development seemed slower than that of their Central Park playmates. It wasn't until 1982 when the boys were 18 and 17 that a definitive diagnosis was made, and their condition given a name, the Fragile X Gene,¹ which was later found to be the most common inherited cause of behaviors associated with retardation and autism.

According to an April 30, 2010 *New York Times* article, "Promise Seen in Drug for Retardation Syndrome", by Busby's godson, **Gardiner Harris**: "One child in five thousand is born with Fragile X Syndrome, with mental effects ranging from mild learning disabilities to retardation so profound that sufferers do not speak, and physical effects that include elongated faces, prominent jaws, big ears, and enlarged testes."

In 2007, Mary Beth co-authored the book, *DEAR MEGAN: Letters of Life, Love and Fragile X* with **Megan Massey**, who is also a mother of two sons born in 1989 and 1991 with Fragile X Syndrome. They met when they both became active in the Fragile X Research

Foundation (FRAXA). The book, written in the form of intimate letters between the two women who are separated in age by a generation, offers hope and support to the millions of parents who care for and love their disabled children. Their correspondence reveals the personal side of parents struggling with the challenges of school and health systems, marriage, and life to care for their disabled sons. It is a heartwarming valentine to these very special children and adults. *DEAR MEGAN* is available online through Amazon.com and other outlets.

FRAXA Research Foundation was started in 1994 by **Katie Clapp** and her psychopharmacologist husband, **Dr. Mike Tranfaglia** of Newburyport, MA, the parents of two children with the Fragile X gene. The couple joined forces with Kathy May, a young mother in Fairfax, VA to start FRAXA to raise funds for research.

Since that time, Mary Beth and David Busby became Board members, with David serving as the foundation's lobbyist for many years and Mary Beth later serving as a vice president. Currently enjoying emeritus status and still very much involved with the Advisory Board, the Busbys act as consultants to the foundation. To date, FRAXA (fraxa.org) has raised \$18 million in research funds.

The Busbys divide their time between Washington, D.C. and Oklahoma City. Mary Beth Busby is a 1997 recipient of the Jessica Cosgrave Lifetime Achievement Award.

¹So called because when viewed under the microscope, one "arm" of the X chromosome appears to be broken, with part of it hanging by a thread. The disease affects both males and females. Although males can only inherit the Fragile X gene through the mother, females can inherit it from either parent. Although a girl might carry the gene, it is often only discovered later through testing and a diagnosis after the condition is discovered in a male family member.

2010 Finch Foundation Grant Awardees

The Finch College Alumnae Association Foundation recently announced the winners of this year's \$2,000 grant. Five outstanding community college students who will enter a four-year college were named by the committee:

Emily Carr graduated from Columbia-Greene Community College, Hudson, NY and will enter SUNY Albany College of Environmental Science & Forestry. Emily's major is bioprocess-engineering. She will study climate change, fossil fuel alternatives and the way humans interact with nature and discovering answers to problems we now have. She is interested in creating a sustainable way of living so her generation and future generations will be able to enjoy all the beauty and happiness that can be found in nature. This summer she is working on a farm in Sweden participating in their planting, care of animals and farm maintenance. Her future plans include obtaining a master's degree, applying for the Innovative and Sustainable Energy Engineering in Scandinavia, and returning to the U.S. with a new wealth of international knowledge.

Klara Kang graduated from LaGuardia Community College, NYC and will enter the Florida Institute of Technology. Klara has wanted to be a marine biologist since she was a little girl in the Czech Republic. She had always been fascinated by Jacques Cousteau and the underwater world. She became a certified open water diver in the United States and studied accounting which seemed more practical for a married mother of two children. She excelled in this and worked in the field while attending LaGuardia CC. Here she studied the effects of global warming, the alarming coral bleaching issue and researched the impact of offshore drilling on marine life. Klara applied to four marine biology programs at Florida colleges and was accepted at them all. She is now 30-years-old and is moving her family to Florida to pursue her degree

and enter the field she loves. While on a work project at LaGuardia CC, Klara developed their new blog for transfer students. Do take a look at it: Transferexploration.blogspot.com.

Tatiana Saurova graduated from Erie Community College, Buffalo, NY and is transferring to the University of Buffalo. When Tatiana's husband was diagnosed with acute myeloid leukemia, she knew life would never be the same and she must prepare for the future. She wanted to know everything about the disease and in doing so, discovered she was captivated by research and chose to enroll at Erie Community College and study the field of pharmacology and toxicology. Tatiana has been chosen for a unique program of pharmacology and toxicology at the State University of New York at Buffalo. This prestigious program accepts only 40 applicants each year. Unfortunately, her husband died this past April and, although she promised him to continue her education, he did not live to see her achieve her goals. Now 34-years-old, Tatiana's goal is to be involved in research and ultimately enter the graduate program of molecular pharmacology and cancer therapeutics.

Bonnie Stas graduated from Three Rivers Community College, Norwich, CT and will enter the University of Connecticut, Storrs. Bonnie's career goals began eight years ago when her three-year-old child could not speak and was diagnosed with classic autism and apraxia. She became interested in speech and language therapy and how to effectively treat autism and apraxia concurrently. She wanted to know more and wants to focus on working with children. Now 37-years-old, Bonnie has two children and her husband is on active duty with the navy. She volunteers with nonprofit Connecticut Family to Family where she is a Health Information Specialist, helping other families with disabled dependents access insurance and respite. Her true passion as a Speech and Language Pathologist began with her son and her understanding of the parent's viewpoint which she now wants to translate to help others.
